

The **GROW** program provides funding to offset expenses for businesses signing their first commercial lease in Baltimore County.

Eligible businesses may receive grants of \$8 per square foot when signing a lease for Class A or Class B office spaces.

\$50,000 to \$250,000

for the acquisition of real estate and equipment, leasehold improvements, and even working capital.




